Main Street Theater (MST) began in 1975 to provide stimulating opportunities for Houstonians of all ages to engage with the performing arts while providing meaningful and challenging professional work for Houston theater artists. We work hard to present theater that reflects the community we serve, particularly in our Theater for Youth, whose audience exactly mirrors the makeup of the city as a whole. Our audience comes to us seeking thoughtful and passionate plays for adults and children, and theater arts activities to immerse youth in performing arts experiences created out of their own ideas and imaginations. This is also what motivates our staff, our artists, and our Board. In the 2015-2016 season, the Main Street Theater presented 614 performances of 15 productions to a total audience of 141,302 audience members at our two locations and our tour throughout Texas.
